### ***Become a Family Support Partner Supervisor!***

The Family Support Partner Supervisor provides support and supervision to Family Support Partners, including overseeing case documentation and reporting; training and development; and ensuring fidelity to Systems of Care, Wraparound and Family Support Partner principles.

**Background:** Family Support Partners provide peer support to youth and families affected by mental health, substance use and related concerns. Family Support Partners assist by helping youth and families identify strengths, assess needs and further develop advocacy, resiliency and self-care skills. Family Support Partners help youth and families successfully connect with community resources, including support and treatment.

Family Support Partners serve families with children up to age 22 who experience one or more of the following: emotional, behavioral, mental health and/or substance use challenges, contact with the social services system or juvenile justice or court system, or who require emergency services or long term community mental health and other supports.
